The AP reporter who spoke with Karen and Keith last week wanted to clarify how we are going to release the Freeh report, and who will see it before it becomes public. Karen mentioned everybody who's interested will get the report simultaneously, which isn't exactly correct. I spoke with Kekst today and we put together a statement about this. AP will put it out first, and then we will put this out on the Openness website. Here's what we want to put out:

Q: Who will review the report prior to becoming public?

A: We expect the Board will be afforded the opportunity to review the report to assure all important areas have been investigated and that there are no factual gaps, but not for editing. The final report will be solely the work of Judge Freeh and his team and no one else has the right to edit the report.
